## Introduction

The state independence of the Republic of Tajikistan, the 32nd anniversary of which is celebrated this year in the republic, is considered a unique event in the history of the country, during the period of independence, at the initiative of the founder of peace and national unity - the Leader of the Nation, the President of the Republic of Tajikistan, respected Emomali Rahmon, radical reforms were carried out in the direction of optimizing the investment climate and the development of the private and entrepreneurial sectors, which give significant results.

As a result of the implementation of an effective policy to ensure stable economic development and strengthen cooperation with international partners, the volume of foreign investments in the national economy aimed at achieving strategic goals increased from year to year, large industrial enterprises were created and operated.

The process of attracting capital funds within the scope of implemented projects, attracting foreign investment and the process of implementing investment projects is worth noting that as a result of the measures implemented by the government of the country and the executive branch of the state authority of the Badakhshan Mountainous Autonomous Region in the direction of ensuring the progress of the regional economy and strengthening beneficial cooperation with development partners, the volume of foreign investment inflows into the region's economy is steadily increasing.

Therefore, as part of the celebration of the 33th anniversary of the state independence of the Republic of Tajikistan, it is planned to hold an International Business and Investment Forum "Pamirinvest 2024" on the topics "Information and communication technologies and innovative activities are one of the most important economic and social sectors", "Attraction of domestic and foreign investment to stabilize the economic and social indicators of the executive branch of the state authority of the Badakhshan Mountainous Autonomous Region" and "Increasing the financial literacy of entrepreneurs in the finance and banking sector".

This forum will provide ample opportunities for the dialogue between entrepreneurs and investors and the Government of the Republic of Tajikistan related to the development of entrepreneurship, including innovative entrepreneurship in the country, including the Badakhshan Mountainous Autonomous Region, strengthening of economic reforms and attraction of domestic and foreign investment.



### Forum aims and objectives:

- attraction of domestic and foreign investment to the economy of the Badakhshan Mountainous Autonomous Region
- analysis of business capacities in Badakhshan Mountainous Autonomous Region;
- search of new methods for attracting domestic and foreign investments in strengthening the region's potential;
- increasing the attractiveness of investment and industry of Badakhshan Mountainous Autonomous Region;
- training and strengthening of the implementation of international standards in the development of industry;
- the role of modern technologies in improving the investment opportunities of the region;
- search for ways to modernize access to financial instruments;
- proposing ways to strengthen cooperation between domestic entrepreneurs;
- preparation of investment projects of various directions;
- considering and finding modern and effective ways to connect domestic entrepreneurs in order to establish effective bilateral cooperation and exchange of experience;
- improving the financial literacy of the private sector in Badakhshan Mountainous Autonomous Region;
- search for ways to modernize access to financial instruments;
- review of existing problems and obstacles of the region in various fields.

### Program

In the courtyard of the entrance hall, an exhibition will be organized for the sale of goods and products of local manufacturers, samples of folk crafts.

Participants of forum will visit the exhibition before the event.

The Forum will include three parts: the official part, work on panels and the B2B session:

After the end of the official part, the work of the Forum will continue in the following panels:

**The first panel:** The sphere of information and communication technologies and innovation activities is one of the vital sectors of the economy and social sphere

**The second panel:** Attracting domestic and foreign capital to stabilize economic and social indicators in the Badakhshan Mountainous Autonomous Region

**The third panel:** Increasing financial literacy of entrepreneurs in the financial and banking sector in the Badakhshan Mountainous Autonomous Region.

### **Forum participants (350 people)**

- Representative of the Government of the Republic of Tajikistan;
- Representatives of ministries and agencies
- Domestic and foreign private sector, commercial banks, leaders and members of associations and business organizations;
- Representatives of foreign compatriots - development partners;

### **Speakers**

Leaders and representatives of state bodies in the field of economy, business and investment, Chamber of Commerce and Industry, tourism, industry, agriculture, Academy of Sciences, development partners, private sector, representatives of foreign companies, specialists and experts will speak in the working section.

### **Face to face meeting (B2B)**

At bilateral face-to-face meetings, entrepreneurs and investors can hold meetings either with heads and representatives of bodies and departments.

In it, the main focus is on establishing business relations between companies, as well as potential investors and suppliers, getting to know more about the working conditions in the fields.

### **Moderators**

Moderators are determined and selected by the State committee on investment and state property management of the Republic of Tajikistan from experts, specialists in the fields or state bodies. Moderators are invited based on recommendation.

### **Information support**

Before the event, during registration, the participants of the forum will be provided with publication materials, brochures on the topics planned for the forum.

Republican and regional mass media will be involved in publishing information, data and videos.

The organizers of the forum will provide the materials, the procedure for inviting and ensuring the participation of media representatives in the event.
